S. R. O. No. 372/2013.—In exercise of the powers conferred by sub-section (2) of section 8 of the Kerala Road Fund Act, 2001 (10 of 2001) regarding levy and collection of user fee on motor vehicles using the transport facility, the Government of Kerala hereby notifies that user fee on mechanical vehicles using the Railway Over Bridges constructed by Roads and Bridges Development Corporation of Kerala Ltd. as per Schedule-I, shall be levied and paid at the rates specified in Schedule-II and hereby authorize the Managing Director, Roads and Bridges Development Corporation of Kerala Limited, Kochi or his authorized representative to collect and retain user fees at the rates specified in the schedule. The notification shall come into force on the date of its publication.

The user fee in subsequent years shall be set/revised as per the following guidelines:

1. An increase of 5% by every two years.
2. The user fee shall be rounded off to the nearest rupees.
3. No user fee would be levied on the following types of vehicles.
 - (a) VIP vehicles and other special categories of vehicles notified as exempted by the Government of Kerala.
 - (b) Two wheelers, three-wheelers and non-motorized vehicles.

For frequent users of the transport facility, user fee shall be levied on the following basis:

- (a) For a return journey at the rate equal to one and a half (1.5) times the user fee for a single journey.
- (b) For two return trips or more in a single day at a rate equal to 3 times of the rate of single journey.
- (c) For a monthly pass an amount equal to the aggregate user fee for 30 single journeys.

The above mentioned rates shall be displayed conspicuously on notice boards erected at suitable places in the vicinity of the bridge/booth for collection of user fee legibly written or printed in English, Hindi and the regional language of the area in which the bridge is situated. Every driver, owner or person in charge of the mechanical vehicle shall, before crossing the permanent bridge or having crossed it, stop his vehicle at the cross bar and pay the fee leviable in respect of the vehicle at the fee collection booth. The person authorized by the Managing Director, Roads & Bridges Development Corporation of Kerala Ltd., Kochi to collect user fee in respect of any mechanical vehicle crossing the bridge shall in return, prepare a receipt in duplicate in the prescribed form and hand over one copy of the said receipt to the driver or owner or person in charge of the vehicle.

The Railway Over Bridges (ROBs) at Koratty-54,67/13-14 (Thrissur District) between Divine Nagar and Koratty Railway stations, Sulthanpet-49,53/10-11 (Palakkad District) between Palghat Town and Puduknagaram Railway Stations. Parappanangadi-174A, 639/14-15 (Malappuram District) between Parappanangadi and Vallikunnu Railway Stations, Devdhar-172, 629/11-12 (Malappuram District). between Tirur and Thanur Railway Stations and Thirunavaya-170, 615/3-4 (Malappuram District) between Thirunavaya-Thanur Stations constructed by Roads and Bridges Development Corporation of Kerala Ltd. will be opened to traffic shortly. User fee has to be levied on motor vehicles entering the bridge under the provisions of the Kerala Road Fund Act, 2001. In exercise of powers conferred by Section 8 (2) of Kerala Road Fund Act, 2001 regarding levy of user fee on motor vehicles using the transport facility, the Kerala Road Fund Board hereby notifies that there shall be levied and paid user fee on Mechanical Vehicles for the use of the two ROB's constructed by Roads and Bridges Development Corporation of Kerala Ltd. as per Schedule-I at the rates specified in the Schedule-II and hereby authorize the Managing Director, Roads and Bridges Development Corporation of Kerala Limited (RBDCKL), Kochi or his authorized representative to collect and retain user fees at the rates specified in the schedule.
