## **Invitation of proposal for Beautifications of Pillars of Edappal Flyover with vertical garden and painting pictures.**

Managing Director RBDCK invites proposals from interested parties for the beautification of the Pillars of Edappal Flyover with vertical garden and painting pictures as per the conditions given below before 5.p.m-6.10.2021

1. The work shall be carried out without making any damage to the flyover structure and without obstruction to the traffic and pedestrians.
2. 50% area shall be beautified with vertical garden and balance area with painting. The pattern and theme of the paintings shall be approved by RBDCK before execution.
3. The agency shall maintain the garden neatly during the contract period including watering, Trimming etc. as and when required.
4. The Agency can display a board of size – 80cmx50cm in which 50% area, the agency can display their logo and 50% area slogans regarding traffic rules shall be displayed. The matter in the board also shall be got approved by RBDCK before preparation of the board.
5. Length of the pillar and diameter are given below:

| Pillar | Height | Dia   |

| P1     | 1.35 M | 1.5 M |
| P2     | 3.25 M | 1.5 M |
| P3     | 4.50 M | 1.5 M |
| P4     | 3.20 M | 1.8 M |
| P5     | 3.05 M | 1.8 M |
| P6     | 4.20 M | 1.5 M |
| P7     | 2.40 M | 1.5 M |

6. An agreement shall be executed with RBDCK by the selected agency.





7. The Agency shall complete the work within 10 days from the date of agreement. The agreement shall be executed within 3 days from the date of letter of acceptance.
8. The agency shall ensure that installation and maintenance of vertical garden and painting shall be carried out as approved by RBDCK. The Agency will be solely responsible for maintenance, upkeep of vertical garden and painting during the currency of the agreement.
9. The Agency shall obtain other required approvals.
10. All costs of construction, maintenance etc shall be the sole responsibility of the Agency
11. The PWD/RBDCK shall be at liberty to carry out their normal work in connection with the maintenance of ROB and the employees of the RBDCK/PWD shall not be challenged or obstructed while moving around in performance of their duties.
12. All the instructions/restrictions of the MORT&H/RBDCK/PWD relating to road visibility and traffic, measures for the safety of the bridge, users of bridge and utility cables etc shall be followed.
13. The PWD/RBDCK officers are authorized to inspect the beautification works at any time without assigning any reason and their instructions shall be followed without any compensation being payable to the Agency.
14. The officers nominated by PWD/RBDCK / Appropriate traffic control authority will inspect the performance of the beautification works at regular intervals. Necessary action as per recommendation of the said Officers shall immediately be initiated against the agency if found to be violating the conditions of the agreement and if performance is not found satisfactory.
15. It shall be the responsibility of the agency to arrange for the electric connection for the purpose at their cost and pay the electricity charges periodically if required for maintenance of the facility.
16. The Agency alone shall be responsible, liable and shall indemnify PWD/RBDCK and Public as the case may be for any risks or damages occurring on account of any accidents due to the electrical installations and vertical garden maintained in the bridge by the agency.
17. The validity of this agreement will be for a period of five years from the date of the agreement.
18. All disputes and differences arising of or in any way touching or concerning this work shall be decided by the Managing Director of RBDCK or his nominee





19. Copy of proof of identity certificate shall be submitted along with the Proposal
