INSTRUCTIONS TO BIDDERS

1. Printed Quotation forms can be obtained from the office of the undersigned and website of RBDCK. Quotations submitted not in such printed forms or Quotations, incomplete in any respect such as unattested errors and corrections etc will be liable for summary rejection.
2. No Quotations received after the specified last date and time will be accepted on any account
3. Details of the work with item wise specifications are given in the subjoined schedule of work. Bidders must quote only a single rate against each item in the Schedule. The rates quoted shall be inclusive ones covering all the operations contemplated in the schedule of works and all incidental works necessary for such operations. The rate quoted shall not be varied on any account whatever and it shall hold good for all items of work done, irrespective of variations of quantity if any
4. Each Quotation should be accompanied by Earnest Money Deposit of amount mentioned in the notice inviting Quotation. It should be produced as Demand Draft on a Scheduled Bank drawn in favour of the officer who has invited Quotations. Quotations without EMD will be summarily rejected.
5. In consideration of the Bidder being allowed to quote for the work, he should keep the Quotation firm for a period of Three months from the last date for the submission of Quotations. Withdrawal of Quotations before this period will entail forfeiture of EMD for the work.
6. The acceptance of the Quotation rests with the officer inviting Quotations who does not undertake to accept the lowest or any particular Quotation.
7. The EMD of unsuccessful Bidders will be refunded as soon as possible after tabulating the Quotations, keeping the EMD of the first three lowest Bidders. EMD of the remaining unsuccessful Bidders will be refunded within a week of acceptance of the successful bidder.
8. The successful Bidder within Three days of receipt of the selection notice shall deposit an amount which along with the EMD shall make up the total amount equal to 5 % of contract amount. This shall be treated as Performance Security for the proper fulfillment of the work. The Performance Security shall be produced in the form of Banker's cheque/bank draft drawn in favor of Roads and Bridges Development Corporation of Kerala Ltd payable at Ernakulam. The Security Deposit will be released to the contractor only after the submission of all reports to the full satisfaction of RBDCK.

9. Time is the essence of the contract. The work shall be completed within 10 days from the date of receipt of written order to commence the work. If the work is not completed by the agreed date liquidated damages will be recovered from the contractor in accordance with the conditions of contract.
10. The rates quoted by the Contractor shall be deemed to be inclusive of all duties, taxes, and other levies payable by the contractor or for any other cause, shall be included in the rates, prices and total amount quoted by the contractor, BUT EXCLUDING GST AT 18% or as decided by the Government from time to time which will be paid in addition to the quoted rates.
