- Bidders are requested to quote rates in the price schedule (BOQ) only. Please do not quote / mention rates anywhere else in the tender other than BOQ. <u>The price should be</u> <u>quoted per cubic meter in rupees only.</u>
- Duly filled and signed quotation should be send by post so as to receive in this office before the time mentioned in the quotation notice. Conditional/In complete bids shall not be considered.
- The validity of contract will be for a period of Six months from the date of signing of contract.
- 4) Earnest Money deposit Rs 500000/-, drawn in favour of Roads and Bridges Development Corporation of Kerala Ltd. The E.M.D of the unsuccessful tenderers will be returned to them only after the completion of tender process.

- 10) The volume of each truck will be measured by company-authorized personnel for billing purposes. Only pre-measured vehicles will be permitted for loading.
- 11) The rock deposited within the ROW should be cleared regularly to keep the site free of hindrances for construction.
- 12) If the contractor fails to start the work within 5 days after signing the agreement, the contract will be automatically stand cancelled. In such cases all costs and damages will be recovered from security deposit.
- 13) The contractor should arrange his own JCB/earth moving machinery for loading purpose.
- 14) Equipment or vehicle provided by the contractor for this use must have valid documents like Registration certificate, Fitness certificate, Tax receipt, Insurance, Pollution certificate and all other documents as required.
- 15) Contractor should cover the truck adequately to prevent spillage and dust pollution and should adhere to all laws of Motor vehicle Department, Road safety and Pollution control board.
