## **INVITATION FOR QUOTATION (IFQ)**

1. Quotations are invited for the supply and planting of demarcation stones along the alignment of Ollal - ROB.
2. Suppliers/Contractors willing to undertake the work shall submit their quotations by filling out the attached BOQ.
3. The specifications mentioned in the BOQ shall be strictly followed.
4. Details of the work, including item-wise specifications, are provided in the attached schedule of work. Bidders must quote only a single rate for each item in the schedule. The quoted rates shall be inclusive of all operations contemplated in the schedule of work and any incidental works necessary for such operations. The quoted rate shall remain fixed and shall not be subject to any variation, regardless of changes in quantity, if any.
5. The number of stones mentioned is indicative, and payment will be made based on the actual number of stones laid at the site. If planting a stone at a particular location is not possible, nail marking or paint marking shall be done at no extra cost.
6. The quoted rate shall be applicable for items in strict compliance with the specifications mentioned in the BOQ.
7. The date of the survey and planting of boundary stones shall be fixed in consultation with the engineer.
8. The planting of stones shall be completed on the same day or within three days of completing the survey work.
9. In case the survey or demarcation stone planting is obstructed due to reasons such as objections from landowners, the work shall resume after resolving such issues without any additional cost.
10. If the stone planting work is partially completed and the remaining work is delayed for more than 30 days due to reasons not attributable to the contractor, part payment for the executed work may be released after withholding 10% as a security deposit. This deposit will be released along with the final payment upon completion of the work.
11. The quoted rate shall be inclusive of TDS, which will be deducted from the payment due to the contractor. The rates quoted by the contractor shall be deemed to include sales and other applicable taxes, including octroi, on all materials required for the execution of the contract.

However, GST, as determined by the government from time to time, will be paid in addition to the quoted rates.

12. RBDCK is not obligated to accept the lowest or any quotation and reserves the right to reject all quotations.
13. Printed quotation forms can be obtained from the office of the undersigned or the RBDCK website. Quotations submitted in formats other than the prescribed printed forms, or tenders that are incomplete (e.g., containing unattested errors and corrections), will be summarily rejected.
