- 1) Quotations are invited for Preparation of Land Acquisition Plan for Punnol ROB in lieu of LC No.224 in Kannur District. (Approximate Length of ROB is 450m).
- 2) The Job involves
 - a. Preparation of LA plan in appropriate scale superimposing the approved alignment plan in AutoCAD and the latest Resurvey Sketch showing the Taluk, Village, Resurvey numbers, Sub Division numbers included in the proposed acquisition and Area Statement showing the extent of land to be acquired in each survey number. The documents shall be in compliance with the Land Acquisition Requisition to be submitted to the District Collector pursuant to RFCT LARR ACT 2013.
 - b. The information concerning the area including ownership of land to be acquired for the implementation of the project shall be collected from the revenue and other concerned authorities and presented along with the strip plans.
 - c. Submission of Corrected LA plan, if required by incorporating missing survey numbers after the joint site inspection with LAO, if any changes are proposed.
